General Information:

1. Permits are required for structures in shoreland areas (regardless of size or cost), installation of onsite sewage treatment systems, erection of signs, and shoreland alterations. Permits are valid for a period of one year from the date of issue. Building contractor license numbers are required for all building permits.
2. Please check with your local township for any permits, inspections or approvals if your property is located in the following townships: Akeley, Badoura, Clay, Clover, Helga, Henrietta, Mantrap, Rockwood, Thorpe and Todd.

Issuance of permits will initiate a review of your septic system. Nonconforming systems will be required to be upgraded. Building permits will not be issued on bare land without a site evaluation by a licensed septic designer on file. Site evaluations are good for one year.

Basic minimum lot dimension requirements for lots located within the Shoreland Management Ordinance jurisdictional area are listed below. All setbacks are minimum horizontal measurements and apply to all lots.
